## Pub purchase to go ahead!

**Great News!** Thank you to everyone who has invested in Exelby Green Dragon Community Pub Ltd.

We now have enough funds to complete the purchase. So far, we have access to over £320,000 of funding raised over the last couple of months to take the project forward.

Whilst being able to purchase the pub we will also continue to offer shares and raise funds to ensure that we can refurbish the pub and cottage to a high standard as well as opening the shop and café. This includes a good margin for contingencies and with share purchases still happening we feel we can go ahead with the funds in hand. Our Share Offer will therefore remain open during September and it would be fantastic if you could pass this message on to others who may be able to invest. Similarly, we can also accept further investments from those who have already done so.

So, we have the confidence to proceed! We intend to put back the non-essential repairs to ensure we get the pub open again as soon as possible with a good quality food and drink offering. We will continue to actively seek further funding to ensure that the Green Dragon is once again the go to pub at the heart of our community and importantly the search is now on to find good tenants to run the enterprise.

We are in good company, the highly successful community pubs in Hudswell and Carlton in Coverdale both followed a similar path and fully support our endeavours. It really is happening. We have a once only opportunity for a community purchase of the pub to ensure it stays as the go to place to eat, drink and socialise at the same time creating a worthwhile community enterprise that will provide a valuable service to shareholders, residents and visitors alike.

We are holding a community meeting on Thursday 13 September at 6.30pm in Alasdair's Granary at the rear of Manor House, Exelby – please join us and hear first hand about our plans and get answers to any questions you might have.
